

## **Pre-Application Criteria**

Hold a baccalaureate degree with a cumulative GPA of at least 3.0 or have completed at least 90 college credit hours with a cumulative GPA of at least 3.0
Complete the required general education pre-requisite courses listed below before starting the MSOT program. Applicants must have a combined GPA of 3.0 of higher in these courses.

- Students accepted for entry into the occupational therapy program must complete all outstanding conditions prior to the start date of the program. However, students may be in the process of finishing a small number of courses in the spring/ summer semesters prior to the start of MSOT classes. Failure to complete the prerequisite courses before the start of the program will result in rescinding admission to the occupational therapy program.
- Students transferring from another occupational therapy program will not be given advance standing.
- Students may take their pre-requisite course work at Cox College or other institutions.



Official acceptance letters will be mailed along with forms for the student to read, sign, and return along with information to complete the admissions process. This will include:

- Submitting all official and final transcripts directly to Cox College
- Submitting a nonrefundable acceptance fee to Cox College which covers expenses including, a background check and a drug screen.
- Submitting health form and proof of immunization status as stated in college catalog and student handbook to Cox College
- Completing the Basic Life Support for Healthcare Provider course from an American Heart Association authorized training facility

Information concerning August Welcome Day and MSOT orientation, faculty advisor assignments, and other program specific materials will be sent by July 1<sup>st</sup>. Accepted students are also encouraged to explore <u>Canvas online learning tutorials</u>.

The entry-level Master of Science Occupational Therapy (MSOT) Program has applied for accreditation and has been granted Candidacy Status by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 4720 Montgomery Lane, Suite 200, Bethesda, MD 20814-3449.

The accreditation process, which takes approximately two years, is designed to start before the first class of students enters the program and completed before the first class graduates. In our Candidacy Application we described to ACOTE how Cox College in its Master's-Degree-Level Educational Program plans to demonstrate compliance with the ACOTE Accreditation Standards. The Program will now continue with the next step, the "Initial Review Process" and continue through the accreditation process. Finally, the program will, upon acceptance of the initial review, pursue the final step in the accreditation process which is an onsite accreditation visit by ACOTE. This is expected in October 2017. Final ACOTE approval is anticipated by December 2017.

An occupational therapy program must be accredited by the Accreditation Council for Occupational Therapy Education (ACOTE) prior to students' graduation for its students to be eligible to sit for the national certification examination offered by the National Board for Certification in Occupational Therapy (NBCOT). In addition, most states require licensure in order to practice; however, state licenses are usually based on the results of the NBCOT national certification examination.

Please note that a felony conviction may affect a graduate's ability to sit for the NBCOT national certification examination or attain state licensure.
